The Premier, in exercise of the power conferred by section 1(1) of the Ministers (Change of Responsibilities and Style) Act 1974, makes the following Order:

Short title

1 This Order may be cited as the Ministers (Change of Responsibilities and Style) Order 2009.

Statutory amendment

2 The enactments specified in column 1 of the Schedule to this Order are amended in the manner specified in column 2 of that Schedule.

Registration (Births and Deaths) Act 1949	In section 1, in the definition of “Minister”, delete “of Labour and Home Affairs” and substitute “responsible for the Registry General”;
Adoption of Children Act 1963	In section 1, in the definition of “Minister”, delete “Social Services” and substitute “Child and Family Services”.
Merchant Shipping Act 2002	In section 2(1), in the definition of “Minister”, delete “minister responsible for shipping” and substitute “Minister responsible for Maritime Administration”.
