The Minister of Transport, in exercise of the powers conferred on him by section 250 of the Merchant Shipping Act 2002, makes the following Regulations:—

**Citation**

1 These Regulations may be cited as the Merchant Shipping (Fees) Amendment Regulations 2004.

**Amendment of Schedule**

2 The Schedule to the Merchant Shipping (Fees) Regulations 1988 is amended —

- (a) in Part III by deleting paragraph 1; and
- (b) by deleting Part IV and substituting the contents of the Schedule to these regulations.

**Commencement**

3 These Regulations shall come into operation on 1 April, 2004.
